TERMS + CONDITIONS

CREW FACED MAKEUP ARTISTRY

Please read these Terms + Conditions carefully, you agree to the Terms detailed below upon confirmation of your booking.

It is the responsibility of the client who books to understand, agree & be responsible for these Terms + Conditions.

Crew Faced Makeup Artistry are a team of Makeup Artists & Hair Stylists that welcomes large parties, micro weddings & elopements. There is no minimum people required for services within 25 kms of the studio unless otherwise agreed.

Your wedding date will be held and then confirmed after your trial. Trial fee is to be paid on the date undertaken & does not form part of the amount owing to the event/ wedding. Trial bookings take place at the Lara based studio unless otherwise communicated and confirmed. An option to forego the trial will be accepted under special circumstances.

Full payment of the services will be requested 2 weeks prior to your wedding day/event with written confirmation of this booking. Details regarding Artists/Stylists arrival time, location & time services expected to be finalised will also be confirmed at this time. Alternative options in payment should be discussed with Jessica prior to this date including cash, transfer, deposits & scheduled or payment instalments. Full payment is also acceptable at any time between the trial date and event/wedding.

A detailed invoice is available at your request. All payments are digitally tracked & confirmed in writing.

The agreed confirmed quote is expected regardless of no-shows, late arrivals where time does not permit completion of services or last minute changes. This ensures covering the cost of extra artists & time in travel planned for your booking. A decrease in number of people for services is not accepted, you may add a replacement or additional people for services at an additional cost should time permit.

Wet hair will incur a \$65 blow dry fee unless otherwise instructed. The client/s should wash & dry hair the day prior. Instructions & tips will be provided at the trial booking regarding hair preparation. If time does not permit the blow dry for hair preparation where the client has not followed this request, full payment of the hair style is expected.

A change of mind in Hair Styling is welcome on the day before hair preparation commences & communicated with the stylist. Change of mind & requests for a 2nd style will attract a separate fee & only if time permits.

Hair extensions or clip in installation attracts the up-styling fee.

For completion time, it is best to consult your photographer as well as allowing time to dress/ travel to the location.

Please allow up to 1.45 mins p/p for both hair/makeup or 1 hr p/p for 2 artists or more.

If paid parking is required at your venue, it is the responsibility of the client to cover this cost and include directions for parking/event/location. Toll fees may be included in your travel quote.

Should the event/wedding be transferred to another date, any payment made thus far is transferrable. A refund will not apply for services already undertaken.

Additional fees may apply for early appointments prior to 7am outside of the studio.

Destination weddings are welcome! Travel over 1hr 50 mins each way will require overnight accommodation of the artists. These costs will be communicated prior to booking.

Charges may apply per artist required for larger parties/destination events.

Services available on location or in studio 7 days/week.

Touch up service is available at an hourly rate. This applies from time services completed to time touch ups finalised & does not include travel cost between locations. Eg- location getting ready to reception venue.

You acknowledge and agree to disclose any medical conditions known to you that may affect the application of services. In doing so, you agree that Crew Faced Makeup Artistry is not liable for, and will indemnify Crew Faced Makeup Artistry for any claims, liabilities, costs, loss and causes of action relating to the personal injury arising directly or indirectly, as a result of your failure to disclose pertinent information relating to the medical and other conditions of those receiving services.
